1. Call to Order

The meeting was called to order at 5:30 pm by Chairperson Ernest Lamphere.

2. Additions to Agenda:

None.

3. Checklist Additions and Statutory Challenges:

Informational and no vote required.

4. Checklist Removals:

Warren Cross moved to accept the list of removals as presented. Motion seconded by Beth Gray. No discussion. Motion passed.

5. Appointment of Poll Workers:

a. Request of Clerk to appoint additional poll workers as needed:

Char Osterlund moved to accept the poll worker assignments as presented (see attached) and to allow the Clerk to appoint additional poll workers as needed. Motion seconded by Lisa Young. No discussion. Motion passed.

6. Appointment of Justices to deliver ballots to physically disabled voters as soon as Absentees become available (17 VSA 2538):

Warren Cross asked aren't ballots being mailed to all voters. Barbara Courchesne confirmed they are, but we do have one request for JP delivery, and it's required by statute.

Mike Martin and Lisa Young volunteered to be appointed to deliver ballots to ill or physically disabled voters. Alice Emmons moved to accept the appointment. Motion seconded by Beth Gray. No discussion. Motion passed.

7. Early Absentee Ballot Processing (17 VSA 2546a):

Barbara Courchesne stated absentee ballots are going to all active voters from the Secretary of State's office. Springfield's ballots have not yet been dispatched. They work through the alphabet of towns so Chester will get theirs before Springfield. She does know M has gone out. We'll have to process those absentees the same way we did in 2020. She would like to do every Tuesday and Thursday through the month of October with two teams of folks opening, and she will run the tabulator. In 2020, we processed over 3,000 absentees, about 1,000 people came to the polls, which is close to what we do on town meeting day so we have two big processes happening at the same time. We processed 200 absentees at the polls, still entering them at 7:00. The idea is to get everything processed as soon as we can. We have a statutory process for opening them and a statutory requirement for a procedure which the Secretary of State gives us and we follow. It worked pretty well in 2020. Steve Matush asked if she is asking for a couple of hours in the morning. Starting Thursday, October 13, she'd like to start with two pairs committed tonight to start that process. Board members can sign up for Tuesdays and Thursdays, and we'll rotate and see how it goes. In 2020, we were here the weekend before the election. She would like to do the process between 10:00 am and 12:00 pm. The procedure is they get run through the machine, everything is tabulated and recorded, the machine with the computer on it goes down into the vault, then back up to selectmen's hall, it gets inspected and checked by everybody to make sure the numbers work out. All board members present, except Alice Emmons, Rebecca Tucker and Lisa Young, advised that they will be available. Lisa Young stated she can be backup, if needed.

Lisa Young moved to accept the early absentee ballot processing. Motion seconded by Mike Martin. No further discussion. Motion passed.

Steve Matush moved to adjourn. Motion seconded by Beth Gray. No further discussion.
